An emergency exists, and I need a temporary restraining order issued immediately without notice to the respondent to avoid irreparable injury. I request a Temporary Order for Protection that will:

- (X) RESTRAIN respondent from causing me or any of the minor children named above any physical harm, bodily injury, assault including sexual assault, and from molesting harassing or threatening me or any of the children above named. (X) EXCLUDE respondent from my residence at 819 O'Farrell as well as my mother's place of work the Community Center ( ) RESTRAIN respondent from interfering with my custody of any of the children named. (X) RESTRAIN respondent from removing any of the children named above from the State.

REQUEST FOR ORDER FOR PROTECTION

I request an Order for Protection that will:

- (X) RESTRAIN respondent from causing me or any of minor children named any physical harm, bodily injury, assault including sexual assault; and from molesting, harassing or threatening me or any of the children named above. ( ) EXCLUDE respondent from my residence at the above address. ( ) GRANT me the temporary care, custody and control of the children when living with me, but subject to any visitation by the respondent the court may grant. (X) DIRECT respondent to participate in appropriate treatment or counseling services. (X) REQUIRE respondent to reimburse me for my costs and expenses in bringing this action. (X) REQUIRE respondent to pay the Clerk of the Court the filing fee and court costs incurred in bringing this action.

REQUEST FOR SPECIAL ASSISTANCE FROM LAW ENFORCMENT AGENCIES

I request the court to order the appropriate law enforcement agency to:
